

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON June 15, 2010

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:30 PM. Village Clerk Jerry Kautz called the roll.

STAFF REPORTS:

<u>VILLAGE MANAGER</u> ~ Mr. Ganek reported the following:

1- The village secured, at no cost, an energy audit for the wastewater treatment plant. The audit will be conducted by the University of Illinois. 2- Staff is submitting an application for reimbursement of \$9,000 for converting traffic lights to LED. Also, staff is looking at upgrades for energy efficiency at Historic Village Hall. 3- A bike path route booklet is being printed for residents, making it easy for families to bike within the Village. Each month a different route will be printed. 4- Staff is doing whatever possible to make sure the Riverfront Square property does not become a nuisance. Police will analyze security issues.

PUBLIC WORKS ~ Mr. Mitchard reported the following:

1- The Jacobs water tower painting is almost complete, with the Jacobs lettering to be added. The tank is being partially filled and tested. 2- Hanson Road berms are almost complete. 3- Old Oak curbing is moving along. 4- Algonquin Hills road reconstruction is going to begin by next weekend. Area residents are being advised.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

- 1- Art on the Fox was a success with a number of artists selling over \$500 worth of product.
- 2- Martini's on Main has placed their tables and chairs on the sidewalk; it spruces up the area. 3- This Friday, our Annual Conservation Community Day will be conducted on the Woods Creek Bike Path. All are invited.

<u>POLICE DEPARTMENT</u> ~ Deputy Chief Urban reported the following:
