



MINUTES OF THE REGULAR MEETING
OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF
ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON
OCTOBER 5, 2010

CALL TO ORDER: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

VILLAGE MANAGER ~ Mr. Ganek reported the following:

1- The McHenry County Council of Governments will meet on October 6 at Biaggi's Restaurant in Algonquin with the main item being a presentation on "How Springfield Works." 2- He will report on another topic of land acquisition in Executive Session.

PUBLIC WORKS ~ Mr. Mitchard reported the following:

1- Algonquin Hill Phase 4 storm sewers are completed. The contractor hit a gas line on Monday that had to be repaired; they will be responsible for the associated costs. 2- Hanson Road is in the final punch list phase with striping completed and looking good. 3- Our snow equipment is being prepared for this winter with the Snow Plan also being updated. 4- The Algonquin cemetery tree trimming and grading are taking place. 5- The long-range Capital Plan is being formulated. 6- The Mamola property on Hanson Road will be graded as soon as the water and sewer hookup is completed.

COMMUNITY DEVELOPMENT ~ Mr. Farnum reported the following:

1- Country Harvest Days will be held this Saturday from 9 a.m. to 3 p.m., and the Cemetery Walk is scheduled from 11 a.m. to 2 p.m. All are invited. 2- GIS work is continuing for the Public Works Department. 3- The dog day care center that was recently approved will open on Friday.

POLICE DEPARTMENT ~ Chief Laine reported the following:

1- The drug take-back event was very successful, with more than 100 pounds of old prescription drugs being collected, and he hopes the DEA will allow more of these projects. 2- The department participated in a simulation of emergency services during a tornado. The training was good for street supervisors to get experience in case of such events.

1- Her office has been involved with property issues, agreement review, and litigation matters.
