STAFF REPORTS:

VILLAGE MANAGER ~ Mr. Ganek reported the following:

1- Explained the time frame for the current Toastmaster Building fire. All departments worked very well with the Algonquin/LITH Fire Protection District in fighting the blaze. Demolition by the State is in progress. Over 600,000 gallons of water were used to fight the fire, and water was used from various zones within the Village so not to affect the residents' supply. 2- The budget process for next year is going to begin in November.

<u>PUBLIC WORKS</u> ~ Mr. Mitchard reported the following:

1- Reported on his department's involvement with assisting the firefighting process at the Toastmaster Building. He commends all of his employees who were involved. 2- The ambulance recently purchased from the fire district has been modified as a service vehicle for the Sewer Division and is available for inspection. 3- The Grand Reserve preconstruction meeting was recently held. - Wetland and open space design work is being formulated for the Grand Reserve. 5- The Golf Club of Illinois berm work is completed and was well received.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

1- The Art Open House will be this Thursday, October 21, at Village Hall with all invited. 2- Staff is working on the new Munis software integration, especially for listing permits.

POLICE DEPARTMENT ~ Deputy Chief Kuzynowski reported the following:

1- He attended a recent Narcotics Task Force dinner where one of our officers was honored for his participation in task force activities. The Board sends its congratulations. 2- The department received a grant for five mobile data processors for squad cars that was greatly needed.

1- Her office has been involved with IDOT property transfer issues for the Western Bypass, reviewing agreements, and community development matters.
