PUBLIC HEARING CONSIDERATION OF MAJOR IMPROVEMENTS IN OLD
TOWN DISTRICT CASE No. PC10-05, 205 LA FOX RIVER DRIVE FOR
REPLACEMENT OF FRONT STAIRS AND RAILINGS.

Mr. Mason reported to the Commission that the Petitioner has applied for a Certificate Of
Appropriateness for the replacement of the front entrance stairs and railing located on the
Property in question.

The Petitioner recently replaced these front steps with new concrete stairs. (Please note
the work was done without a building permit and/or review by the Historic Commission.
The plans the
Petitioner had for this project would enhance the exterior of the building

Staff feels the requested COA for replacement of the front stairs and railing is compatible
with the appearance of the home and in line with the Preservation Code. Staff
recommends approval of the
COA with the following condition: That Petitioner shall obtain a building permit for the
stairs and handrail which shall conform to all village codes and requirements.

Additionally, the Petitioner's application for a COA included the addition of a roof
overhang and wood support posts, converting the entrance from an open front stoop to a
porch use. No historical evidence has been submitted showing the home with a porch
design such as is currently proposed.

The Petitioner is willing to appear before the Planning and Zoning Commission

To seek the required variance needed to complete this project., since code requires a
covered porch to be a minimum of 30 feet from the front property line.

After further discussion Member Nee moved to recommend approval of the request for a COA to replace front stairs, stoop and handrailing on property located at 205 LaFox River Drive Case No. PC10-05. Additionally, the Commission recommended approval of the Petitioner's preliminary design plans to add a roof overhang for the front porch plus wooden support posts or columns, should the Petitioner pursue and the village ultimately grant a variance that would allow the Petitioner to move forward with this addition to the front porch project. This preliminary design approval is granted to free the Petitioner from having to come back before this Commission, provided there are no changes to the current proposed designs. A Public Art Program Open House will be held at the Algonquin Village Hall on October 21 from 6 to 8 P.M.


