

MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON NOVEMBER 2, 2010

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

VILLAGE MANAGER ~ Mr. Ganek reported the following:

1- The GIS Mapping System is now hosted in-house which will eliminate outsourcing and save the Village the expenditure. 2- Reported Riverside Square project update. The court approved a public auction to be held in January. The starting bid must be at least \$1,250,000. Village staff is still pursuing a demolition order. 3- The Committee of the Whole for November 9, 2010 is cancelled.

PUBLIC WORKS ~ Mr. Mitchard reported the following:

1- Algonquin Hills Phase 4 is moving along. Curb work and binder coat are completed. Sidewalks will be next. 2- The Golf Club of Illinois landscaping has been completed by staff. 3- Fall tree planting and ash borer-infected tree removal is occurring at a rapid pace. 4- Four snow and ice removal trucks are ready for an unexpected early storm. 5- Bid opening will take place for the Manchester Lakes storm sewer project.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Farnum reported the following:

1- Two new businesses that are opening are American Mattress on Randall Road and Chi Spa on Main Street. 2- The recent Public Art Open House was attended by 80 people.

POLICE DEPARTMENT ~ Chief Laine reported the following:

1- The Department received a grant from IDOT for a traffic enforcement program during the Thanksgiving holiday. 2- Traffic surveys are taking place before winter sets in. 3- The Department is starting the budget process.

VILLAGE ATTORNEY ~ Ms. Cahill reported the following:

1- Her office has been involved with property issues, litigation matters, and ordinance review.
