Village Awarded EECBG Grant

The Village of Algonquin has received \$4,500 in grant funding from the Energy Efficiency and Conservation Block Grant (EECBG) Program to perform insulation and weatherization enhancements at Historic Village Hall. This grant award will

fund the project 100% and not require any Village funding. Village staff trained in thermal imaging performed a survey of this facility identifying areas in need of insulation and weather stripping. These heat efficiency measures will be installed in December and will result in lower natural gas heating costs for the Village.

These simple enhancements, such as adding insulation and installing weather stripping, are a perfect project for the do-it-yourselfer to help save on energy costs at your home this winter. Check out www.energystar.gov for more information on this and other energy efficiency applications.

Emerald Ash Borer Update

The Emerald Ash Borer (EAB) infestation in Algonquin reached new heights in 2010. This pest will unfortunately eliminate the ash tree species as a viable plant in our area.

At this point, the Village has identified over four hundred and fifty (450) Villageowned trees that are infested. All of these trees have either been removed or are slated for removal. Emerald Ash Borer is now officially found in all areas of the Village. The infestation continues to dramatically increase, and, by next year at this time, the community will have lost over 1,000 public and private trees.

Treatment options available to the resident include homeowner products (available at local retailers) or treatments provided by qualified arborists. The only product endorsed by the Illinois Department of Agriculture is *Tree-age*, which is only commercially available and must be applied by a professional.

With the number of trees slated to fail, the Parks and Forestry Division is facing an incredible challenge. Your patience, as they work diligently to manage this event, is greatly appreciated. Sidewalk Snow Removal

With winter weather officially here, please remember that the Algonquin Municipal Code states that any person occupying a property within the Village shall remove snow and ice accumulating on the adjoining sidewalks within 24 hours after any snowfall has ceased. If snow and ice cannot be removed, the surface shall be sanded or otherwise treated to lessen the hazard for pedestrians until the climate permits removal.

Please remember that this code pertains to all front, back, and side area sidewalks that adjoin your property. Snow should never be blown or shoveled into the public streets as it is prohibited by Village code. Such placement of the snow may create a driving hazard for other motorists, especially if the Village plows have already passed through the area. Winter Parking Regulations

Don't forget that winter parking regulations are in effect and parking is prohibited on any public street in the Village between the hours of 2:00 a.m. and 5:00 a.m. The winter parking hours will be in effect until April 15, 2011.

In addition, it is unlawful to park on the street after any snowfall of 2 inches or greater unless the street has been cleared of snow. The snowfall parking ban is in place for your safety and will remain in effect until snow removal operations have been completed. Violators will be issued tickets. Residents with special parking issues should contact the Algonquin Police Department at 847-658-4531. Short-term parking may be allowed under special circumstances.

Holiday Tree Collection

Waste Management will collect holiday trees on your normal collection day beginning on January 3 and ending January 14 at no charge.

In order for a tree to be collected, it must be placed at the curb or the edge of the road by 7:00 a.m. on the collection day. All lights and decorations must be removed. Trees should not be placed in plastic bags and any trees over six (6) feet tall should be cut in half so one person can handle them. Also, trees should be placed on top of the snow. Trees buried under snow could result in Waste Management not collecting them. Please contact Waste Management Customer Service at 1-800-796-9696 with any refuse or recycling inquiries.
