

MINUTES OF THE REGULAR MEETING

OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON JANUARY 4, 2011

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:30 p.m. Village Clerk Jerry Kautz called the roll.

<u>PLEDGE TO FLAG</u>: Clerk Kautz led all present in the Pledge of Allegiance.

1. Vince Lobosco, 570 Tanglewood Court, Algonquin, voiced complaint and asked for a stop sign on Highland Avenue at Tanglewood. He said he had a close call today and wants a stop sign placed at the corner. He was informed by President Schmitt that a traffic study has to take place by the police department before the Village could even consider a sign. Mr. Ganek added that certain warrants are required by State of Illinois guidelines in order to install any stop signs in the Village. Algonquin would be subject to liability if it just installed stop signs anywhere they wanted and injury or damage occurs.
