

# Minutes of the Regular Meeting of the President and Board of Trustees of the Village of Algonquin, McHenry & Kane Counties, Illinois Held in the Village Board Room on December 17, 2019

<u>CALL TO ORDER</u>: President Schmitt called tonight's meeting to order at 7:30 PM. Deputy Village Clerk Michelle Weber called the roll with the following Trustees Present: Debby Sosine, Janis Jasper, Jerrold Glogowski, Laura Brehmer, Debby Sosine, Jim Steigert, John Spella. Staff in Attendance: Village Manager, Tim Schloneger; Community Development Director, Russ Farnum; Senior Planner, Ben Mason; Assistant Public Works Director, Michele Zimmerman; Police Chief, John Bucci; Village Attorney, Kelly Cahill; and Deputy Village Clerk, Michelle Weber.

<u>PLEDGE TO FLAG</u>: Deputy Clerk Weber led all present in the Pledge of Allegiance.

David Aschenbrenner, 330 Fairway View Drive – Raised concerns of the pending plans to be submitted to the Village to convert Terrace Hill Golf Course into a residential subdivision. He is not in favor of the development. He asked the Board to respect the comprehensive plan that was put into place and to please be thorough with their review of the petitioner's request.

President Schmitt explained that he nor has the Board seen the plan put forth. Before the Board reviews it, the plan will be reviewed by the Planning & Zoning Commission and there will be a Public Hearing. Barring any changes, Mr. Mason indicated the Public Hearing tentatively is scheduled for January 13, 2020
