I am so **disappointed** to hear that the Trails of Woods Creek development is on the agenda tonight and the board is voting to move forward with the rezoning. You have had an overwhelming response from the public that you have chosen to ignore.

We have asked you to reduce the number of homes planned. The number of homes has been increased. We've asked you to address the existing traffic concerns before increasing the amount of traffic. The board denies the issue and has no viable plan to address the issue. We've asked you to please postpone this NON-EMERGENCY issue until it is safe for the public to be unmuted and address you as whole in person.

This request has been completely ignored. You haven't met us halfway on any issue that concerns the public and instead congratulated yourselves on your conservation plan.

The public has responded with unprecedented numbers on this issue. The pressing issue for most was the traffic. You heard numerous firsthand experiences regarding the traffic and safety issues in the area. In response the board denied there was a traffic issue. We would like to ask you, why would so many people take time out of their evening to watch a board meeting if there was no issue. What is the average public involvement on zoning issues? What makes you more informed than the residence living with and dealing with the traffic issues on a daily basis.

We heard many of the resources used to calm traffic wouldn't work but we didn't hear any suggestions of what would work. There is already and issue here, how is adding nearly 300 more homes going to help this issue. The theory that once the construction on Algonquin Road is done the traffic issues will resolve itself is nonsense. Someone in the first meeting rightly brought up that traffic is a habit.

People using Bunker Hill to get to Algonquin commons are going to continue to use Bunker Hill to get to Algonquin Commons. The completion of construction may reduce the commuter traffic but it's going to do nothing to reduce those moving locally including the nearly 300 new homes added to the area. Those that live in local subdivisions are going to continue to Use Terrace Hill and other neighborhoods to move locally. Speed is not a deterrent, it's about convenience.

Voting yes on rezoning for 272 homes without first addressing this issue in a concrete way would be negligent.

I have asked this before, I will ask it again, what is the damage to Algonquin in waiting to vote on this issue until the public can address them in person? Ask yourself how differently these meetings would feel if you were facing 100 people and not 100 emails. With an issue with this much interest is unfair to rob the public of the impact a

large group can have. It will be much easier for you to vote yes on rezoning while sitting in the comfort of your own homes with public muted. Without a plan to move dirt this year there is no reason not to wait. You owe us the ability to put up our best fight. Voting yes on this issue right now is cowardly. Face your community.

A. Amending Chapter 33 Liquor License Control

In accordance with an ordinance passed in 2013 limiting the number of allowable liquor licenses in all classes to the number of licenses issued at that time; staff recommends passing an Ordinance effective May 1, 2020 changing the number of available liquor licenses as follows:

- Class A-1 license: Decrease to twenty-six (26) from twenty-eight (28) Closure of Buddy Z's and LaPalma Mexican Cuisine
- Class A-3 license: Decrease to six (6) from seven (7) Closure of Houlihan's
- Class C license: Decrease to one (1) from two (2) Closure of Terrace Hill Golf Course

There was consensus of the Committee of the Whole to forward this to the Board for approval.

A. Consider an Agreement with Christopher Burke Engineering for the Rt. 62 Bridge Deck Overlay- Construction Oversight and the Sleepy Hollow Project Oversight and GASBY Entry

Following is a Task Order Amendment for Construction Inspection Services related to the following Projects: • Route 62/Fox River Bridge Deck Overlay (IDOT Project)- \$15,000 Sleepy Hollow Project- \$20,000

The IDOT project requires coordination between IDOT, their contractor, the Stage 3 Utility Engineer and contractor, as well as Village staff. The In-House Engineer will provide that coordination.

The Sleepy Hollow Project, while substantially complete, has numerous punch list items that need to be addressed/completed as well as the assembly of GASB data for the new infrastructure assets the Village has constructed.

Christopher B, Burke Engineering Ltd. (CBBEL) will perform these tasks as-needed and required for the combined not to exceed amount of \$35,000. These items were included in the Fiscal Year 2020-2021 Budget for Capital Street Improvements.

Consensus of the Committee of the Whole is to forward to the Board for approval.

B. Consider Extending the Agreement with Christopher Burke Engineering for Engineering Consulting Services

Public Works has been utilizing engineering staff from Christopher B. Burke Engineering Ltd. (CBBEL) since June of 2019. When the Project Manager departed in July, the workload increased significantly. During FY 2020-2021 budget discussions, money was budgeted in the Water and Sewer and Street Improvement Capital Improvement accounts to continue using CBBEL staff during this current fiscal year; \$100,000 in each Capital account for a total of \$200,000. We have been very pleased with the work that has been performed by CBBEL staff and they are a great addition to our team at PW, as well as other departments in the Village.

Therefore, we recommend that the Task Order Amendment be approved by the Committee of the Whole for In-House Engineering Services with CBBEL in the amount of \$200,000 for FY 2020-2021.

Consensus of the Committee of the Whole is to forward this item to the Board for approval.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF ALGONQUIN, McHenry and Kane Counties, Illinois, as follows:

SECTION 1: Section 33.07-B, Paragraph 2, 4, and 9 Number of Licenses Issued, of the Algonquin Municipal Code shall be amended as follows:

- 2. Twenty-six Class A-1 licenses at any one time.
- 4. Six Class A-3 licenses at any one time.
- 9. One Class C license at any one time.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 4: This Ordinance shall be in full force and effect April 22, 2020, approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.

ORDINANCE NO. 2020 - O -

An Ordinance Authorizing the Execution of a Declaration of Covenants with the Village of Cary

WHEREAS, the Village of Algonquin (the "Village"), McHenry and Kane counties, Illinois, is a home rule municipality as contemplated under Article VII, Section 6, of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois.

WHEREAS, the Village has entered into an intergovernmental agreement with the Village of Cary; and

WHEREAS, the Declaration of Covenants is intended to implement the intergovernmental agreement with the Village of Cary and it is in the best interest of the Village of Algonquin to place such covenant on the Algonquin Territory at such, if any, that the Village of Cary acquires title to the Algonquin Territory; and

WHEREAS, the Declaration of Covenants is attached hereto as Exhibit A and that said Declaration be approved.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the VILLAGE OF ALGONQUIN, McHenry and Kane counties, Illinois, as follows:

SECTION 1: The Declaration of Covenants is hereby approved and the Village Manager is hereby authorized and directed to execute the Declaration on behalf of the Village.

SECTION 2: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF CARY AND <u>THE VILLAGE OF ALGONQUIN</u>

This Agreement made and entered into as of the _____ day of ______, 20__, by and between the VILLAGE OF CARY ("Cary") and the VILLAGE OF ALGONQUIN ("Algonquin"), each being Illinois municipal corporations.

WITNESSETH

WHEREAS, -Cary and Algonquin are authorized to enter into this Agreement pursuant to the Illinois Compiled Statutes and by Article VII, Section 10 of the 1970 Constitution of the State of Illinois; and

WHEREAS, a portion of Cary's boundary with Algonquin bisects certain property commonly known as the Cary Lake at Rotary Park, a former gravel mine previously owned and operated by Meyer Material, (hereinafter described as the "Rotary Park"), which condition causes a separate taxation of property that is under common ownership and use; and

WHEREAS, Cary and Algonquin desire to consolidate under one jurisdiction the Rotary Park for the purpose of simplifying the levy and payment of taxes related to such lots and the reduction of the taxes borne by the owners of the same.

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained and other good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, and pursuant to the authority vested in the parties under the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1, et. seq. and all other applicable authority, the parties agree as follows:

1. <u>Consolidation of Jurisdiction</u>. For the purpose of consolidating the jurisdiction in which the Rotary Park is located, the parties agree to perform the following duties pursuant to Section 7-1-25 of the Illinois Municipal Code and the terms otherwise expressed within this Intergovernmental Agreement:

A. The Village of Algonquin shall adopt an ordinance providing for the disconnection of that portion of Rotary Park lying in the Village of Algonquin, more specifically depicted and described as both Parcel 1 and Parcel 4 on Exhibit A, ALTA/NSPS Land Title Survey, attached hereto and incorporated by reference ("Algonquin Territory").

B. The Village of Cary shall adopt an ordinance providing for the annexation of the Algonquin Territory.

C. Algonquin shall, within 90 days of adoption of the disconnection ordinance, file with the Recorder of Deeds and County Clerk of McHenry County, a copy of Algonquin's disconnection ordinance, along with an accurate map of the property to be disconnected.

D. Cary shall, within 90 days of adoption of the annexation ordinance, file with the Recorder of Deeds and County Clerk of McHenry County, a copy of Cary's annexation ordinance, along with an accurate map of the property to be annexed.

E. Cary and Algonquin shall be solely responsible, at their own cost, for the recording and filing of the foregoing disconnection and annexation ordinances.

2. **Recreational Uses**. In the event any portion of the Algonquin Territory is or becomes owned by Cary, improved for recreational purposes, and made accessible for public use, Cary covenants that residents of Algonquin shall be charged in parity with the residents of Cary for the opportunity to access all or any part of the recreational improvements, notwithstanding any contrary ordinances, regulations or policies otherwise adopted by the owner of the property. This covenant shall survive the termination of this Agreement; it being the intent of Cary and Algonquin for this covenant to remain enforceable for so long as any part of the Algonquin Territory is owned by Cary, its successors and assigns, improved for recreational purposes, and made accessible for public use. Cary agrees to sign, notarize and record the declaration of covenant attached hereto and incorporated herein as Exhibit B. This covenant shall be expressly included in any deeds of conveyance from Cary to any public body for any part of the Algonquin Territory, but the failure to include it shall not affect its enforceability.

3. <u>Cooperation</u>. Cary and Algonquin promise to extend whatever cooperation and perform all acts and execute all documents as are deemed reasonably necessary to implement the intent of this Agreement.

4. <u>Miscellaneous</u>.

A. This Agreement may be amended in writing by mutual agreement of the parties.

B. This Agreement shall not grant any rights to any third party nor shall any third party rely on or gain any expectation resulting from the Parties' respective promises and covenants contained herein.

C. Notice. Any notices or communications required under this Agreement shall be given by any means capable of providing a written, dated confirmation of receipt to the address set forth below, or to such other address which the party may provide by giving notice thereof in conformance with this section. E. This Agreement may only be terminated prior to the term set forth above by mutual agreement of the parties where the parties have agreed in writing that the Agreement

will terminate as of a date certain. In the event either party has failed to perform its obligations under the Agreement and remains in default after ninety (90) days written notice of such failure, the non-defaulting party's sole remedies shall be an action in law, in the event of there being an adequate monetary remedy, or for specific performance, where the default is with respect to an executory covenant provided for herein.

F. This Agreement may be executed by separate counterparts. It shall be fully executed when each Party whose signature is required has signed at least one counterpart even though no one counterpart contains the signatures of all the Parties.

G. Nothing in this Agreement is intended or shall be construed as establishing a relationship of agency, partnership, or joint venture between the parties hereto. Each party hereto shall retain the sole right to control its own employees.

H. All questions of interpretation, construction, enforcement and all controversies with respect to the Agreement shall be governed by the applicable constitutional, statutory and common law of the State of Illinois; provided, however, that this Agreement shall be construed as being drafted by both parties in equal measure and with equal bargaining position.
