



MINUTES OF THE REGULAR MEETING
OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF
ALGONQUIN, McHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON
APRIL 5, 2011

CALL TO ORDER: Village President John Schmitt brought the regular meeting to order at 7:37 p.m. Village Clerk Jerry Kautz called the roll.

ROLL CALL: Present: Trustees Brian Dianis, Jim Steigert, Robert Smith, Deborah Sosine, Jerry Glogowski, John Spella. A quorum was established. Staff in attendance – Bill Ganek, Russ Farnum, Craig Arps, Bob Mitchard, Steve Kuzynowski. Attorney – Kelly Cahill.

PLEDGE TO FLAG: Boy Scouts from Troop 368 led all present in the Pledge of Allegiance.

ADOPT AGENDA: Moved by Smith, seconded by Dianis, to adopt tonight's agenda, including Executive Session to discuss pending litigation. Voice vote: ayes carried.

AUDIENCE PARTICIPATION:

1. Charles Mueller, 2225 Barrett Drive, Algonquin, voiced strong concern about the penalty fees for those who are late in paying their water bills saying the percentage is too excessive. He was informed by Mr. Ganek that the late fee was after two months of nonpayment by the homeowner and was for a shutoff and turn-on fee. Then Mr. Mueller complained about the water quality and lawn restrictions in the summer. He stated the Village should bring in Lake Michigan water. President Schmitt said that is out of the question due to the millions of dollars it would take to complete the project. He also responded that water is a finite commodity, and conservation is most important to ensure that future generations have clean water.
