<u>VILLAGE CLERK'S REPORT</u> Deputy Clerk Weber announced future meetings and indicated election packets for the April Consolidated Election will be available on the Village's website September 22.

#### STAFF REPORTS:

#### *ADMINISTRATION*:

Mr. Schloneger: Our thoughts are with Clerk Kautz and his family. Fiscal 2022 Budget preliminary planning has begun. Dates have been put out to meet with department heads. We have a good fiscal plan in place. COVID has presented various challenges, but we have confidence that we will still be able to meet our basic needs for our residents while maintaining flat taxes, like we have for so many years.

#### Mr. Kumbera:

- 1. In lieu of a formal financial resiliency plan update he covered highlights of the latest Treasurers Report. Fortunately, we did see sales tax rebound showing about 6% below our budget versus 21% in May. We also saw substantial growth in home rule sales tax a 9% variance versus a 32% variance in May. Video gaming came back in May, so there again was an increase in revenue.
- 2. The US Treasury released formal guidance CARES funding. The Village will be submitting reimbursement for our entire funding of \$1.4 million. We will keep the Board informed of the status of that reimbursement.

### **COMMUNITY DEVELOPMENT**: Russ Farnum

- 1. Staff has been fielding a number of calls from businesses regarding economic development and development inquiries.
- 2. Staff has been working on property maintenance complaints, abatement, and political sign complaints.
- 3. Public Arts Commission met last week and has begun planning the 2021 Art on the Fox event.

# POLICE DEPARTMENT: John Bucci

1. Ten members of the Algonquin Police Department are participating in the Virtual Row 4 Dough – LETRSO event. Due to COVID, many fundraising events for LETRSO have been cancelled and therefore the funding for Special Olympics has been significantly impacted.

- This is a virtual event where participants have to row 26 miles, receiving donations for each mile rowed. He thanked Sgt. Walker for all of his work with LETRSO, and all of the members of the PD who continuously support and donate to LETRSO, representing APD in such a professional manner.
- 2. Tuesday the 22nd is the written exam for the Sergeant Promotional List there were 15 letters of interest, and therefore those individuals are eligible to take the written exam. He congratulated all 15 officers for taking the first step in this process and wishes them the best of luck.
