

MINUTES OF THE REGULAR MEETING

OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALGONQUIN, MCHENRY & KANE COUNTIES, IL HELD IN VILLAGE HALL ON

MAY 17, 2011

<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:35 p.m. Village Clerk Jerry Kautz called the roll.

COMMITTEE & CLERK'S REPORTS:

<u>COMMITTEE OF THE WHOLE</u> ~ Trustee Steigert reported there was a Special Committee of the Whole meeting prior to tonight's meeting. The following action is required:

Under Public Works & Safety

1. Moved by Steigert, seconded by Glogowski, to accept the proposal for Royal Hill Construction Observation Services and award the contract to Trotter and Associates, Inc. in the amount of \$36,974. Roll call vote: voting aye – Steigert, Glogowski, Dianis, Smith, Spella, Sosine. Motion carried: 6-ayes, 0-nays.

<u>VILLAGE CLERK</u> ~ Clerk Kautz reported future meetings of Boards and Commissions.

STAFF REPORTS:

<u>ADMINISTRATION</u> ~ Mr. Ganek reported the following:

1- The Village's second annual e-waste recycling event was a huge success with more vehicles and participants than last year. 2- Staff reports that the Village has sold a combination of 70 rain barrels and composters; this number almost equals all that were sold county-wide.

<u>COMMUNITY DEVELOPMENT</u> ~ Mr. Arps reported the following:

1- Georgia's, a new family restaurant on Randall Road, will open on Monday May 23. 2- The Founders' Days Committee Carnival Fundraiser will begin tomorrow May 18 and run through Sunday, May 22, in the Great Escape parking lot on Randall Road.

PUBLIC WORKS ~ Mr. Mitchard reported the following:

1- Tree planting and removal are taking place throughout the Village, with all trees purchased under a grant program being in the ground. Further grant money is being sought. 2- South Harrison Street restoration work is underway. 3- Royal Hill Road work is to begin very soon. 4- A sidewalk trip hazard survey is being completed in various parts of the Village, and repairs immediately follow.

POLICE DEPARTMENT ~ Chief Laine reported the following:

1- D.A.R.E. graduations are upcoming at Algonquin Lakes and Neubert Schools. 2- A recent police basketball game with the Lake in the Hills Department netted \$600 to benefit the Special Olympics.

3- Police memorial services will be held in Batavia at Mooseheart with personnel from our police department participating.

VILLAGE ATTORNEY ~ Ms. Cahill reported the following:

1- Their office has been involved with administrative matters and ordinance reviews

- 1- Trustee Sosine praised everyone who assisted at the e-waste recycling event this past Saturday.
- 2- President Schmitt will travel to Springfield to ask the State to not take municipalities' share of income tax revenue as this would have dire economic impact on all communities.
