<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 7:45 p.m. Deputy Village Clerk Michelle Weber called the roll.

### **STAFF REPORTS**:

### *VILLAGE MANAGER* ~ Mr. Ganek reported the following:

- 1. The fall recreation brochure is going to the printer and will be distributed to residents next week.
- 2. Founders' Days was quite a success. Thank you to Founders' volunteers and to Police and Public Works for doing a great job to ensure a safe and fun event.

# COMMUNITY DEVELOPMENT ~ Mr. Farnum reported the following:

- 1. Ross Dress for Less will be occupying the old Circuit City space. They are to open October 8, 2011.
- 2. Five Below will be opening in a space near JC Penney August 18, 2011.
- 3. The Public Art program will be taking applications from artists through Friday, August 5, 2011, for the 2011/12 season.

# **PUBLIC WORKS** ~ Mr. Mitchard reported the following:

- 1. Founders' Days was quite successful considering the storm-causing floods. Mr. Mitchard would like to acknowledge his staff for putting forth the extra effort to arrange the park to be safe and suitable for the fest.
- 2. Bunker Hill patch that was completed at night has been done. The pavement rides a little rough, so staff will be revisiting this site to improve the work that was done.
- 3. Jacobs Tower. The painter and a representative from the paint company inspected the tower and determined that the paint did not adhere in many locations. Samples were taken, and full forensic testing will be completed; the results should be supplied within two weeks. A report will be submitted to the Village Manager once the test results come back. President Schmitt would like confirmation that the paint problem was not on the interior, just on the exterior. Mr. Mitchard confirmed the problem is just exterior.
- 4. Still working on storm cleanup for almost a month now. Arrowhead Subdivision and cemetery cleanup was completed last week.

## <u>POLICE DEPARTMENT</u> ~ Chief Laine reported the following:

- 1. This was the first full Founders' Days where the new distribution of personnel was deployed. It seemed to work very well with minimal improvements needed. The supervisors are reviewing the overall to see what should be improved upon.
- 2. The booth at Founders' for National Night Out had many inquiries regarding neighborhood watch. It was a great way to get neighborhood watch information out to residents. Trustee Smith commended the police staff on their professionalism and knowledge at the Founders' booth.
- 3. On Saturday, July 30, 2011, the department was able to have a seatbelt enforcement zone from 9:00 p.m. to 1:00 a.m. which was paid for by IDOT. This

resulted in 21 seatbelt violations, 9 child safety seat violations issued, and some other minor equipment infractions. No DWI violations were issued.

# <u>VILLAGE ATTORNEY</u> ~ Ms. Cahill reported the following:

1. Their office has been working with Community Development issues, liquor issues, and ongoing litigation.

<u>CORRESPONDENCE & MISCELLANEOUS</u>: Trustee Smith would like to congratulate the staff for the recreation brochure. He is glad to see the program succeed. President Schmitt would also like to recognize all the staff that was involved in getting Towne Park in order for Founders' Days; he realizes it was quite an undertaking.
