<u>CALL TO ORDER</u>: Village President John Schmitt brought the regular meeting to order at 8:00 PM. Village Clerk Jerry Kautz called the roll.

PLEDGE TO FLAG: Village Clerk Kautz led all present in the Pledge of Allegiance.

<u>ADOPT AGENDA</u>: Moved by Spella, seconded by Glogowski, to adopt tonight's agenda as printed, deleting item 16, Executive Session. Voice vote; ayes carried.

The SEECOM Dispatching Center is now operating for Algonquin and fourteen other agencies. He announced the Village received an award recognizing excellence in its annual budget presentation.

<u>PUBLIC WORKS DIRECTOR</u> ~ Mr. Mitchard reported the following:

Cornish Park update; silt fences have been installed around affected areas. Tree removal has been completed, utilities are being installed, and the La Fox River area sidewalks are being completed. Water Treatment Plant 3 work continues. Well 13 is being pumped and tested. The Ice & Snow Removal Plan is prepared with equipment at the ready. His staff is working on the Capitol Improvement plan Budget.

<u>COMMUNITY PLANNING DIRECTOR</u> ~ Mr. Mihelich reported the following:

The Economic Development Commission will be working on its budget request. The Plan & Zoning Commission meeting will be canceled this month. The third lane on Randall Road in front of the BP station will be completed soon.

His office is working on various Village plan reviews. The southwest sanitary sewer works continues
