#### **Electric Aggregation in Algonquin**

At their December 6 meeting, the Algonquin Village Board approved an ordinance submitting a referendum question to voters of whether the Village should have the authority to arrange for the supply of electricity for its residential and small

commercial retail customers.

Electric deregulation in Illinois allows consumers to purchase their electric supply on the open market. Please note that this only applies to <u>supply</u> and not <u>distribution</u>, which is handled exclusively by ComEd. Electric aggregation allows for municipalities to collectively negotiate electric supply on behalf of its constituents with the goal of achieving a lower rate than the consumer could individually. Currently, communities that have implemented an electric aggregation program have saved over 20% in electric supply costs (source: Illinois Commerce Commission).

A referendum question authorizing the Village to proceed with electric aggregation will be on the March 20, 2012 ballot. Frequently Asked Questions (FAQs) and other information on the program will be available at www.algonquin.org and in informational pamphlets that will be available at Village Hall.



## Sidewalk Snow Removal

With winter weather officially here, please remember that the Algonquin Municipal Code states that any person occupying a property within the Village shall remove snow and ice accumulating on the adjoining sidewalks within 24 hours after any snowfall has ceased. If snow and ice cannot be removed, the surface shall be sanded or otherwise treated to lessen the hazard for pedestrians until the climate permits removal.

Please remember that this code pertains to all front, back, and side area sidewalks that adjoin your property. Snow should never be blown or shoveled into the public streets as it is prohibited by Village code. Such placement of the snow may create a driving hazard for other motorists, especially if the Village plows have already passed through the area. ### **Winter Parking Regulations**

Don't forget that winter parking regulations are in effect and parking is prohibited on any public street in the Village between the hours of 2:00 a.m. and 5:00 a.m. The winter parking hours will be in effect until April 15, 2012.

In addition, it is unlawful to park on the street after any snowfall of 2 inches or greater unless the street has been cleared of snow. The snowfall parking ban is in place for your safety and will remain in effect until snow removal operations have been completed. Violators will be issued tickets. Residents with special parking issues should contact the Algonquin Police Department at 847-658-4531. Short-term parking may be allowed under special circumstances.

This is a FREE service available to water customers to have your water bill paid automatically from your banking account. #### **Reduce Heating Costs**

Stay warm and reduce heating costs this winter by doing the following simple items:

- Caulk around windows and replace weather stripping around doors to seal out cold air.
- Draw curtains closed to decrease drafts at night.
   Open curtains to let in sunshine to help warm the room during the day.
- Lower the thermostat a few degrees at night and when you are not home.
- Wrap up in a blanket or put on a sweater instead of turning up the heat.
- Install a programmable thermostat.
- Tune up your furnace yearly and change furnace filters often.
- Insulate your attic.

#### **Village Holiday Hours**

Village offices will be closed on 12/23, 12/26, and 1/2. Waste Management Service will be delayed by one day for the entire week of 12/26 and 1/2. Happy Holidays!

#### **Holiday Tree Collection**

Waste Management will collect holiday trees at no charge on your normal collection day beginning on December 27 and ending January 13.

In order for a tree to be collected, it must be placed at the curb or the edge of the road by 7:00 a.m. on collection day. All lights and decorations must be removed. Trees should not be placed in plastic bags, and any trees over six (6) feet tall should be cut in half so one person can handle them. Also, trees should be placed on top of the snow. Trees buried under snow could result in Waste Management not collecting them. Please contact Waste Management Customer Service at 1-800-796-9696 with any refuse or recycling inquiries.

#### **Garbage Cart Placement**

The Village of Algonquin, along with Waste Management, would like to remind residents about the proper placement of your refuse, recycling, and yardwaste containers to ensure proper collection on your service day and for Village maintenance of the roadway.

Containers should be placed curbside so that automated collection may take place. Acceptable areas include on your driveway approach, the lawn just behind the curb, or on the road shoulder where curbs do not exist. Additionally, please remember that containers should NOT be placed in the actual roadway. This presents a safety issue for passing traffic and prohibits Village crews from properly maintaining the roadway, including leaf collection service, street sweeping, and snow removal. Please note that placing obstructions in the roadway is prohibited by the Algonquin Muncipal Code.
