# Algonquin Adopts Parks and Recreation Master Plan

In April, the Algonquin Village Board adopted a Parks and Recreation Master Plan to develop actionable items for Village parks and recreation services to strive to accomplish over the next ten years. The Village maintains over 22 miles of trails, 554 acres of natural areas, 21 developed park sites totaling 174 acres, an aquatic facility, and hundreds of recreation programs.

"Our community highly values park and recreation services, which adds to the high quality of life our residents have become accustomed to and expect in Algonquin," stated Village President Debby Sosine. "This plan sets the policy vision for these services that is consistent with resident input over the next ten years."

Some plan recommendations that are included in the Village's current budget plan include conceptual park plan development for Towne Park, tennis court replacement at Gaslight Park, play structure replacement at Hill Climb Park, and design work for the restoration of Woods Creek (Reach 5) open space. ## FY 21/22 Budget

On April 6, 2021, the Village Board unanimously approved the Fiscal Year 2021-2022 annual budget for the Village of Algonquin. The Village's \$75.0 million budget is used as a tool to assist Village officials in making sound and rational choices for the provision of public services.

The Arbor Day Foundation announced that the Village of Algonquin is again named a Tree City USA community for its commitment to urban forestry. This is the 25th year in which Algonquin has received this designation.

## **Every Drop Counts: Water Conservation Regulations**

The Village of Algonquin would like to remind residents the importance of water conservation and how to save water. Simple ideas for saving water include covering your swimming pool when not using it, doing only full loads of dishes/clothes, turning off water when brushing your teeth, watering landscaping early morning or at night, using a rain barrel, setting your mower blades higher and fixing leaks right away. The Village reminds you that summer watering restrictions are in place. To check current water system status, see signs posted on primary streets in the Village, call us at 847-658-2700, or look on the Village's website www.algonquin.org/waterstatus.

**CONSERVATION:** *Green* signs indicate outside water use is permitted except for watering landscaping and lawns which is prohibited between the hours of 9:00 a.m. and 6:00 p.m.

**EVEN/ODD:** Yellow signs indicate even/odd days for watering before 9:00 a.m. and after 6:00 p.m. Even addresses may only water on even calendar days, and odd addresses may only water on odd calendar days before 9:00 a.m. and after 6:00 p.m.

**EVEN/ODD 6:00-9:00 A.M.:** *Orange* signs indicate even/odd days for watering only between the hours of 6:00 a.m. and 9:00 a.m. Even addresses may only water on even calendar days, and odd addresses may only water on odd calendar days from 6:00 a.m. to 9:00 a.m.

**RESTRICTED:** *Red* signs indicate no outside water use is allowed at any time. This includes all use of water outside, such as washing vehicles, power washing, and watering landscaping.
